COOKIE POLICY AND CLARIFICATION TEXT

PANDA ALÜMİNYUM A.Ş. ("Company") as a data controller, we use various cookie data files and other technologies in order to ensure safe and complete use of our internet services and to improve your experience, to store user preferences, to compile statistical information and to protect your privacy. Your personal data are collected through these cookies and other technologies.

With this Cookie Policy and the Clarification Text, it is aimed to inform you about the collection and processing of personal data through cookies and other technologies used during your visit to our website. The processing of personal data through cookies and other technologies is carried out per the Personal Data Protection Law ("PDPL") and other relevant legislation.

Almost every website uses cookies today. Like most websites, we use cookies to provide you with a better, faster and safer experience. A cookie is a small text file that a website places on your computer, phone or any other device to collect information about your visit to that website. Cookies are necessary to facilitate your browsing during your visit and to make the site user-friendly, and they do not cause any harm to your device. Cookies and other technologies help to analyze the visiting habits and obtain information about your visits to our website. When you visit the same site again with the same device, your browser checks whether there is a cookie stored on your device on the site name. If there is a record, it transmits the data in the record to the website you are visiting. In this way, the website understands that you have visited the site before and determines the content to be sent to you accordingly.

1. THE METHODS AND LEGAL GROUNDS OF COLLECTION OF PERSONAL DATA

Your personal data is collected electronically based on the legitimate interest of the Company as a data controller, due to your visit to our website.

Your collected personal data can be processed within the scope of the personal data processing conditions and purposes specified in Articles 5 and 6 of the PDPL.

2. PURPOSES OF PERSONAL DATA PROCESSING

The Company collects some personal data such as your IP address, internet surfing activities by using cookies for the purposes as following;

- to obtain some technical data in order to use the website more effectively,
- to meet the need for information about your preferences and habits of browsing and using the website,
- to fulfill its legal and contractual obligations stemming from the Law No. 5651 on Regulation of Publications on the Internet and Combating Crimes Committed by Means of Such Publication and other relevant legislation.

3. TRANSFERRING OF PERSONAL DATA

Except for "third party cookies" on the company's website, the information stored in cookies is not transferred to any real or legal person and is used exclusively by the Company.

4. COOKIE TYPES AND INTENDED USE

Both first-party cookies (placed by the Company website) and third-party cookies (placed by servers other than the Company's website) are used on the Company website.

The main purpose of using cookies is to provide convenience to users, and in this context, cookies can be categorized in four groups:



Session Cookies: These cookies allow the use of various features such as transferring information between web pages and systematically remembering the information entered by the user and are necessary for the proper functioning of the Company website.

Performance / Analysis Cookies: These cookies collect information about the frequency of visiting the pages, the total time users spend on the relevant page, and the purpose of using the site, and are used to increase the performance of the Company website.

Functionality Cookies: These cookies remind the pre-selected options for the convenience of the user, and they aim to provide advanced internet features to the users within the scope of the Company website.

Advertising and Third Party Cookies: These cookies are used to identify and present content that may be of interest to you, including advertising content. These are cookies belonging to third parties and allowing the use of some functions on the Company website and tracking advertisements.

5. MANAGING COOKIES

The preferences of our visitors and users regarding the use of cookies and similar technologies are important. If you do not want cookies to be placed within this framework, you can manage the cookies.

Browsers generally accept cookies automatically. You can remove, prevent or limit cookies by following the instructions provided in the "help" menu of your internet browser or by visiting www.allaboutcookies.org or <https://www.youronlinechoices.com>.

When you manage the cookies, please note that although you can continue to use our website, some features and services on our site may not work properly or your access to some features and services may be limited.

6. THE RIGHTS OF DATA SUBJECTS

Under Article 11 of PDPL, data subjects have the following rights:

1. to learn whether his/her personal data are processed or not,
2. to request information if his/her personal data are processed,
3. to learn the purpose of his/her personal data processing and whether this personal data is used for intended purposes,
4. to know the third parties to whom his/her personal data is transferred at home or abroad,
5. to request the rectification of the incomplete or inaccurate data, if any,
6. to request the erasure or destruction of his/her personal data under the conditions laid down in Article 7 of PDPL,
7. to request notification of the transactions made according to Articles 5 and 6 to third parties to whom personal data have been transferred,
8. to object to the processing, exclusively by automatic means, of his/her personal data, which leads to an unfavorable consequence for the personal data subject,
9. to request compensation for the damage arising from the unlawful processing of his/her personal data.

The data subject shall make the requests relating to the implementation of this Law to the data controller in writing or by other means to be determined by the Personal Data Protection Board. The data controller shall conclude demands in the request within the shortest time by taking into account the nature of the demand and at the latest within thirty days.

The demands are free of charge. However if the action requires an extra cost, fees may be charged in the tariff determined by the Personal Data Protection Board.

7. AMENDMENTS

As a company, we can opt out of using the cookies we use on our website, change their types or functions, or add new cookies to our site.

In this context, we reserve the right to make changes in this Cookie Policy and Clarification Text. These changes come into effect upon publishing on the website.
